**3. Special Presentation by the Winners of the 2017 Excellence in Eloquence Competition**

Chair McDougald provided background information on how the Board-wide speech competition was revived by two Grade 8 teachers, Darwin Chan and Michael Dzis, to help celebrate students who possessed effective speaking skills and, with a committee of volunteer teachers, ran a tournament called Excellence in Eloquence. She acknowledged the work of the committee members who were present in the audience. Commenting that the tournament is a wonderful addition to the oral communication section of the curriculum, Chair McDougald noted that 100 schools participated in the event. The winners received a medal, trophy, and plaque for their school, and also have the opportunity to present their speeches at the Regular Meeting of the Board.

Christina Pissarouk, a student at Shelter Bay Public School and winner in the Junior division, spoke on causes and effects of depression. Shivam Suri, student at Macville Public School and winner in the Intermediate division, delivered a speech on awareness and dangers of diabetes. Chair McDougald congratulated the students and thanked them for their presentations. She expressed appreciation for support of the school principals, teachers, and parents who were present in the audience.

Arising from Item 6.1, Retirements, Chair McDougald noted the retirement of Associate Director of Equity and Instructional Support Services, Scott Moreash, effective September 30, 2017. She stated that Scott Moreash has been a committed educator in Peel for 33 years, starting as a teacher in 1984, and holding a variety of roles, culminating in his appointment as Associate Director of Instructional Support Services in 2013. Chair McDougald expressed appreciation for the work of Scott Moreash in Peel, his understanding of teaching and learning, strategies for student success, and knowledge of the Peel system. On behalf of the Board, Chair McDougald thanked Scott Moreash for his commitment and dedication to students and the community, and wished him well for the future. Director of Education, Tony Pontes, described Associate Director Moreash as a passionate educator and champion of equity and inclusion. He congratulated Scott Moreash on his retirement, and extended best wishes. Trustees speaking also acknowledged the work of Scott Moreash, and expressed their appreciation for his commitment to Peel, prompt assistance to trustees, pleasant demeanour, energy, and astuteness.

Referring to Item 6.2, a trustee congratulated Don Ball on receiving the Prime Minister's Award for Teaching Excellence. She also acknowledged Diana Wang-Martin's passion and drive to encourage women into the field of science and technology. The trustee spoke positively about the Science Technology Engineering Mathematics (STEM) Conference, the largest student run conference in Canada, and Glenforest Secondary School's student mentoring partnership with Nahani Way Public School's Robotics Club.

A trustee referred to Item 6.3, Crossing Guard Appreciation Day, and acknowledged the work of crossing guards to keep children safe.

Referring to Item 6.4, Follow-up Letter in response to the Minister of Education's letter regarding reporting of EQAO assessments, a trustee commented that the information session with EQAO representatives provided a better understanding of EQAO testing. She highlighted Peel DSB's belief that the participating students method of reporting is more accurate, and expressed hope that the Ministry will agree with the Board's view.

With respect to Item 6.10, TD Bank Community Leadership Scholarships, Chair McDougald congratulated two Peel DSB students, Twinkle Mehta of Glenforest Secondary School and Ranbir Singh of Castlebrooke Secondary, who were awarded 2016-2017 scholarships valued up to \$70,000 each for four years, towards tuition and living expenses. She noted that this is a major achievement as two Peel DSB students were selected from among 20 students across Canada who won this outstanding award for Community Leadership. Chair McDougald commended TD Bank for supporting students.

In regard to Item 6.11, Peel Children's Aid Services Honour Roll, Chair McDougald congratulated Trustee Carrie Andrews on being selected for the Honour Roll in recognition of her volunteer work. Trustee Andrews has been a volunteer at Peel CAS since 2009 and has initiated the Holiday Wishes Program, a successful outreach program that encourages community involvement.

**14. Count Me In Peel – Report on the Findings of the 2016-2017 Workforce Census**

Associate Director of Instructional Support Services, Scott Moreash, stated that the Workforce Census conducted in November 2016 was intended to obtain information on Peel DSB's diverse employee makeup, through a survey of 22 questions. He advised that the report provides a general overview of the self-reported data collected, and some initial recommendations and action plans which will be finalized in fall 2017. He highlighted that the Analysis and Reporting Committee will consist of Peel DSB stakeholders to guide and steer actions related to the Workforce Census. Scott Moreash thanked Manager of Workplace Equity, Farrell Hall, for his work on the Workforce Census and acknowledged the involvement of Trustees Rick Williams and Harkirat Singh on the census work. He invited Farrell Hall and Jaspreet Pabla, Equity Officer, to present the data.

Using a PowerPoint presentation, Farrell Hall highlighted the finding from The Journey Ahead initiative, to collect and analyze data, with a goal to achieve inclusion for all, through continuous progress on equity. He stated that 11,084 employees participated in the Workforce Census and the response reflects 66.3% of all Peel DSB's permanent employees. He explained how the questionnaire was organized and noted that in an attempt to collect accurate data, employees were offered options to choose from. Reviewing the report, he presented data on organizational and workforce demographics which included: participation by employee group; employees in a position of responsibility; work location; employment status and length of service; country of birth; age and retirement plans; residence in or out of Peel Region; disabilities; gender identity; education; racial identity; self-identification of indigenous people; ethnicity; religion or spirituality; languages spoken. Farrell Hall emphasized the strengths identified by the census, such as, a positive participation rate, diversity indicated by 148 different countries of birth, 117 languages spoken, and 41.8% of employees communicate fluently in more than one language; 82% of employees have university degrees and 23% have graduate degrees. Noting that recommendations, key themes, and action items are contained in the report, he acknowledged the work of the Research and Accountability, and Curriculum and Instruction Support Services departments.

Chair McDougald thanked Associate Director Moreash for his leadership on this initiative and expressed appreciation for the report as a starting point for future work. Trustees' questions of clarification were responded to regarding: action plan will include a review of gender split among positions of responsibility and senior administration; data accuracy may depend on the respondents' understanding of the questions; data is not reported in cases of small cell count of less than 10; hiring practices for racialized staff; data may be affected by higher number of younger or fewer older respondents; questions can be rephrased in the next census to allay any fears. Trustees speaking acknowledged the significant amount of work done on this project and thanked Scott Moreash, Farrell Hall, and staff who worked on the report.

**15. Graduation Rates 2015-2016**

Associated Director Moreash stated that the high graduation rate is a reflection of the hard work and dedication of Peel teachers and support staff and family members who work together to ensure student achievement and well-being. He noted that once again this year, according to Peel DSB calculations, Peel's 5-year graduation rate is 93%, and higher than the provincial average of 87%. He thanked Carol Speers, Superintendent of Education, Alternative Programs, for her leadership and invited her to present the report.

Superintendent Speers recalled that, in 2005, the Ministry of Education began to track graduation rates as a measure of success. Using a PowerPoint presentation, she provided an overview of graduating rates for 2015-2016. She stated that 87% of Peel's students completed the Ontario Secondary School Diploma over a 4 year period and 93% over a 5-year period. The Ministry calculations show Peel's 5-year graduation at 88%.

Carol Speers explained the difference between Peel's method and the Ministry's method of calculation, noting that Peel does not include students who are not working towards a secondary school diploma, such as students with developmental disabilities and in vocational level 1 classes, as well as students who are enrolled at the beginning of the year but leave Peel during the academic year. Carol Speers reviewed the 4 and 5-year data for all students, showing trends over time and the break-down of data according to gender, English Language Learners (ELL), special education needs, students in Pathways programs, and Social Risk Index. Providing an analysis of non-graduating students, Carol Speers noted that the percentage has been reducing over the years, and she described the Pathways programs available to assist non-graduating students to meet requirements to graduate.
